# **Virtual Programming Update**

Ms. McEachern stated that there were no updates. Mrs. McEachern mentioned Youth Services now offers virtual Story Time three times per week.

### **Library Re-Opening**

The Board discussed the importance of instituting more programs, but to do so will require an increase in staffing. Mrs. Cannon stated job openings have been posted for Librarians, Library Assistants and Pages, expecting potential new hires to be interviewed by the new Director. Mrs. Cannon suggested the Board prepare a list of priorities for the new Director's arrival. Ms. McEachern went over the difficulty of programming with current staff shortages.

### **In-Person Board Meetings**

Board members discussed whether to move to in-person Board meetings or continue with Zoom meetings amid concerns over the current uncertainties with the virus' ever-changing impact. Some Board members stated that it should be a unanimous vote to return to in-person meetings. A hybrid version was discussed as an option.
